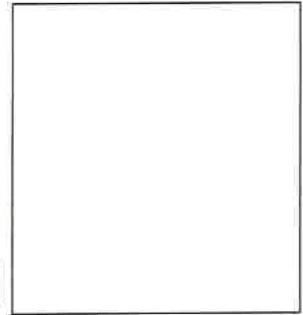

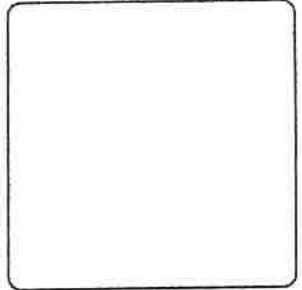

Please be informed that the Saudi Authorities in the kingdom have implemented the Fingerprints System.

Under this system, any worker entering Saudi Arabia and found to have illegally left his employer or has any pending case with the Saudi Authorities in the past can be easily identified through his fingerprints. He will be immediately deported.

Therefore, recruitment agencies are now required to obtain a written assurance from the worker that he has never been deported from Saudi Arabia before. The Agencies should keep said written assurance in the workers file.”

- 2. That I have been shown and given a copy of such Memorandum;
- 3. That, in compliance therewith, I am executing this Affidavit to assure all concerned, including and especially the Saudi and Philippine government authorities, that I have never been deported from the Saudi Arabia before;
- 4. That I further represent and warrant that I did not illegally leave my previous employer/s in Saudi Arabia and I have no pending case with the Saudi authorities;
- 5. That, in the event that my assurance, representation and warranty hereinabove turns out to be false, I shall be fully and solely responsible for the legal consequences thereof such as, but not limited to, denial of my visa application, cancellation of my visa, cancellation of my employment contract, cancellation of my POEA/OWWA/Philhealth processing, non-admission upon arrival in Saudi Arabia, non-issuance of iqama, cancellation of my iqama, termination of my employment contract, deportation, repatriation to the Philippines;
- 6. That I shall also be liable for the payment/reimbursement of the costs of processing my documents by Saudi and Philippine government authorities as well as the costs of my travel to and from Saudi Arabia;
- 7. That I am executing this Affidavit to attest to the truth of the foregoing and for whatever legal purpose it may serve.
